This Amendment No. 1 is made and entered as of 18th day of December 2019 (“Effective Date”), and amends that Public School Academy Contract made and entered as of July 1, 2020 (“Contract”) by and between Detroit Public Schools Community District (“DPSCD”), a Michigan public school district and statutory body, and Rutherford Winans Academy (the “PSA”), a Michigan non-profit corporation.

WHEREAS, DPSCD and the PSA entered into the Contract pursuant to Part 6A of Act No. 451, Public Acts of Michigan, 1976, as amended (the “Code”); and

WHEREAS, the Board of Directors of the Academy (the “Board”) adopted a resolution dated 18th day of December 2019, authorizing Charter Amendment to add 7th grade beginning the 2020-2021 School Year & 8th grade beginning the 2021-2022 School Year (the “Resolution”)

NOW, THEREFORE, for and in consideration of the covenants, terms and conditions herein contained, and for other good and valuable consideration, the sufficiency and receipt of which are hereby acknowledged, the parties hereby agree as follows:

1. Article VI is hereby deleted and replaced in its entirety to read as follows:

6.01 Enrollment Capacity. The PSA serves in grades Kindergarten thru 8th grade

2. Exhibit A to the Contract is amended to delete and replace the Article VI relating to Enrollment Capacity.
3. Except as expressly modified herein, the Contract shall remain unchanged and in full force and effect.
4. The Amendment may be executed in counterparts, each of which may be deemed an original, and all of such counterparts together shall constitute one and the same agreement.

IN WITNESS WHEREOF, the parties have caused the Contract Amendment No. 1 to be executed by their respective duly authorized officers as of the day and year indicated herein, to

be effective as of the Effective Date.
